Dear Parent/Guardian,

Together with LMS administration, the Board of Education has established guidelines for outside lunch. **Going out for lunch is a privilege reserved for 8<sup>th</sup> grade students on Monday thru Thursday under the following guidelines:**

1. **Permission slip signed by parent/guardian**
2. Students must wear their **IDs**.
3. **Academic success:** If a student fails two or more subjects on their report card, he/she must remain in the building for lunch until such time that the progress report or next report card shows improvement. If grades improve, the lunch privilege will be reinstated.
4. **Positive behaviors in school:** Students who receive an **out-of-school suspension** will forfeit their privilege and must remain in the building for lunch for the marking period.

If a student receives **two or more "N"s in conduct** on their report card, he/she must remain in the building for lunch until such time that the progress report or next report card shows improvement. If behavior improves, the lunch privilege will be reinstated.

5. **Attendance:** If the student has accumulated 6 or more un-excused days absent, or if he/she has received 6 or more tardies to school or to the same class, the lunch privilege will be removed for the marking period.
